Through this service, data is overwritten, protecting your intellectual property and employee and customer information from a breach, while ensuring compliance with your internal and external regulations.

## EMC Certified Data Erasure for CLARiiON

EMC meets with you to ensure the proper disposal of your confidential data. This service includes these steps executed by EMC Global Services:

- Identifies CLARiiON arrays that are to be erased
- Verifies that the customer has backed up information on the identified arrays, if necessary
- Executes the erasure process with data overwrites of 3X (default), 5X, and 7X with a combination of random patterns on the selected arrays
  - Pass 1 - overwrites with a character
  - Pass 2 - overwrites with the character's compliment
  - Pass 3 - overwrites with a random character pattern
  - Verifies the successful completion of the erasure and the relevant log files are given to the customer
- Creates and present the Certificate of Completion to the customer, demonstrating compliance
- Provides to the customer the disk drives that could not be erased for final disposition
